

## Help build The Big House through financial support.

An important way in which you can be part of establishing The Big House, to help young people who are facing difficult issues and help the church to care for them, is through giving financial support.

At present, we need both large sums of money for a premises and smaller amounts to meet ongoing running costs. Regular giving by standing order is a very effective and simple way of helping us with our running costs. It helps us to budget effectively and to pay our bills. If you prefer to send a single gift (just as welcome!), you can send a cheque, made payable to "The Big House (Ireland)", to the address above; it is not advisable to send cash by post.

Setting up a standing order involves instructing your bank to make regular payments. You can do this by completing the form below and sending it to us at the address above (not to your bank). If you use telephone or online banking you may be able to set up a standing order (not a direct debit) directly; however, it is helpful if you let us know the amount you're giving and how often.

Whether you are setting up a standing order or giving a single gift, if you are a UK taxpayer you can increase the value of your gift by up to 28% by completing the Gift Aid Declaration and returning it to us, as you will appreciate this can make a big difference!

Gift Aid Notes: 1) You can cancel this declaration at any time by notifying The Big House. 2) You must pay an amount of Income Tax or Capital Gains Tax at least equal to the amount we claim (currently 28% of your gift). 3) If you pay a higher rate of tax you can claim further tax relief in your self-assessment tax return.
