But by supporting The Big House financially you can help us to grow in response to the specific needs of young people.

Regular giving by standing order is a very effective and simple way of helping us grow as we a staff team and our volunteer team, it helps us to budget effectively and to pay our bills. If you prefer to send a single gift (just as welcome!), you can send a cheque, made payable to "The Big House (Ireland)", to the address above.

Setting up a standing order involves instructing your bank to make regular payments. You can do this by completing the form below and sending it to us at the address above (not to your bank). If you use telephone or online banking you may be able to set up a standing order (not a direct debit) directly using our bank details on the form; however, it is helpful if you let us know the amount you're giving and how often.

Whether you are setting up a standing order or giving a single gift, if you are a UK taxpayer you can increase the value of your gift by up to 25% by completing the Gift Aid Declaration and returning it to us, as you will appreciate this can make a big difference!
